Nelson M.: Area 54 Open House Picnic 6-24-2012– Approximately 175 people attended , \$228.00 was collected in the contribution basket. Seed money was \$200.00 a total of \$443.00 was spent. We were unable to return the seed money.

Special Needs: Roosevelt T. On 5-10-12 Ron O. and I met with Joanna at Green Leaf and she mentioned the possibility of starting an A.A. meeting at the facility. She also discussed teaching ASL basic skills for a six week course for up to 10 people at a price of \$50.00 per person. She also made some suggestions for the proposed Special Needs Pamphlet. Archives: Tim H I continue to file minutes and treasurer reports to our Repository in Akron. I gave Jim S. the showcase and books for the State Convention.

Alternate Delegate's Report:

Ohio State Convention - The Hotel has extended our \$75.00 per night rate until July 17th. We are waving the late fee for the registration, so those registering at the door only pay \$21.00. We have over 140 registrations, 85 banquets and 79 luncheon tickets sold, so we do have extra to sell, we must give the hotel a final count on Wednesday, July 18th. The hospitality committee will have access to the hotel as early as 8:00 am Friday. The dance will be Friday night. Saturday night will have a talent show hosted by Lisa from OYPAA. The Service Workshop will be held Aug. 19th. The Committee Chairs, 4 DCMs along with the Area Officers will share their experience and what the position actually entails.

Delegate's Report:

In the second quarter of 2012 through Corrections Correspondence Service we connected 338 incarcerated AA's with outside members. Since December 9, 2011 a total of 6018 e-books, 3,192 Big Books and 2,826 copies of the Twelve & Twelve were sold. According to the recent survey conducted the average sobriety of members is 10 years; members attend an average of 2.6 meetings per week; 65% of the members are male; 35% are female; I am still available to do Conference reports.

Jamie B – Singleness of purpose, the GSR to carry accurate information to the group at a group conscious meeting. They are not there to argue about it, just keep them informed of what AA does and does not do. If all of us don't do this it is giving the impression that we condone what they are doing.
