## The Northeast Ohio Area 54 Assembly

### 1/18/09 Meeting:

75% of Area 54 has GSRs/DCMs. In our district, District 4B, The Dry People's Club, does not have representation. Volunteers are encouraged!

A motion was made/passed for District 13, the area surrounding Canton, to be restructured to allow better conference representation.

An ad hoc committee will revise/update the GSR Fact File. An ad hoc committee will review any potential savings on mail if we secure a not-for-profit registered entity status.

Anyone interested in enclosing AA related materials in the Area 54 newsletter may do so at a low rate.

Reconciliation of the 2008 Treasurer Report revealed an unexplained \$1,000.00 surplus. The 4th quarter Treasurer Report was approved with a request

for details on the \$708.61 amount cited for contingency costs.

## How the Voice of the Each AA Group is Heard by the AA World

The GSR takes the decisions of the home group conscience that affect AA as a whole to the AMC.

For Example: The home group conscience believes that AA as a whole should change the written definition of a closed meeting.

The home group's GSR presents the group's request/opinion to the AMC, which is attended by other GSRs in Summit County.

If other GSRs agree with that home group's request to raise the topic at the next N.E. Ohio Area 54 Assembly, then the DCM, who represents the AA groups in Summit County, pre-

sents the topic at the Assembly. (The Assembly is a meeting of all of the GSRs and DCMs throughout N.E. Ohio, where topics are presented and ruled upon.)

The Assembly rules on the issue by way of the Third Legacy Procedure. (The Third Legacy Procedure is when an issue is won by two thirds of the votes, instead of the customary process wherein issues are won by anything more than 50%.)

If the issue wins (carries) at the Assembly, then the topic will be taken to the annual AA General Service Conference that takes place each Spring.

The Area Delegate is the representative from N.E. Ohio who carries our message to the Conference. (The Conference is the final authority on issues effecting AA as a whole and it is attended by Area Delegates from around the world.)

If the issue carries at the General Service Conference, the decision is implemented throughout the world by AA World Services, located in New York City.

For Example: The home group's recommended change to the written closed meeting definition is reworded in all AA Conference Approved Literature.

*"Besides, we have stopped fighting anybody or anything. We have to!"*
